

Public Safety Officers' Benefits Program: 180-Day Report as of May 15, 2021

The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance's (BJA) Public Safety Officers' Benefits (PSOB) Program provides death and education benefits to survivors of fallen law enforcement officers, firefighters and other first responders, and disability benefits to officers catastrophically injured in the line of duty.

In the six-month period ending May 15, 2021, a total of 414 claims were decided, 393 at the PSOB Office level and another 21 on appeal. Of the 146 death and disability claims decided at the PSOB Office level, 111 (76%) were approvals and 35 (24%) were denials. Of the 14 Hearing Officer appeals decided, 4 (29%) were approvals and 10 (71%) were denials. Of the 7 BJA Director appeals decided, 5 (71%) were approvals and 2 (29%) were denials. Of the 247 education claims decided, all (100%) were approvals.

Of the 886 claims that were pending at the conclusion of the reporting period, 680 were PSOB Office level claims¹ and 206 were appeals. Of these 886 claims, 385 (43%) have been pending for one year or more. For the 680 PSOB Office level claims pending at the conclusion of the reporting period, 222 (33%) have been pending for one year or more. For the 206 appeals pending at the conclusion of the reporting period, 163 (79%) have been pending for one year or more. Of note, the continued loss of staff impacted the claims determined in this reporting period. Restoring PSOB staffing levels is a priority in 2021.

² As noted in the last 180-Day Report, the data reporting feature for the PSOB online portal and case management system (PSOB 2.0) has been developed and is in use. The new features include quality checks to ensure the accuracy of information provided in these reports, including data regarding September 11th exposure claims. System dashboards generate lists of pending applications and claims, and determined claims, and PSOB obligation and payment amounts are also captured in the system.

Because different staff perform different functions to produce a completed determination approving or denying every claim for benefits, the most meaningful indicator of claims processing is the number of determinations issued in the reporting period.
