

**Public Safety Officers' Benefits Program: 180-Day Report as of May 29, 2018**

The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance's (BJA) Public Safety Officers' Benefits (PSOB) Program provides death and education benefits to survivors of fallen law enforcement officers, firefighters and other first responders, and disability benefits to officers catastrophically injured in the line of duty.

In the six-month period ending May 29, 2018, a total of 571 claims were decided, 544 at the PSOB Office level and another 27 on appeal.

Of the 669 claims that remained pending at the conclusion of the reporting period, many claims were pending the submission of basic required documents. 374 of these claims have been pending for more than one year. Of the 669 claims pending, 133 are for exposure due to rescue, recovery and clean-up efforts following the September 11, 2001, terrorist attacks.
